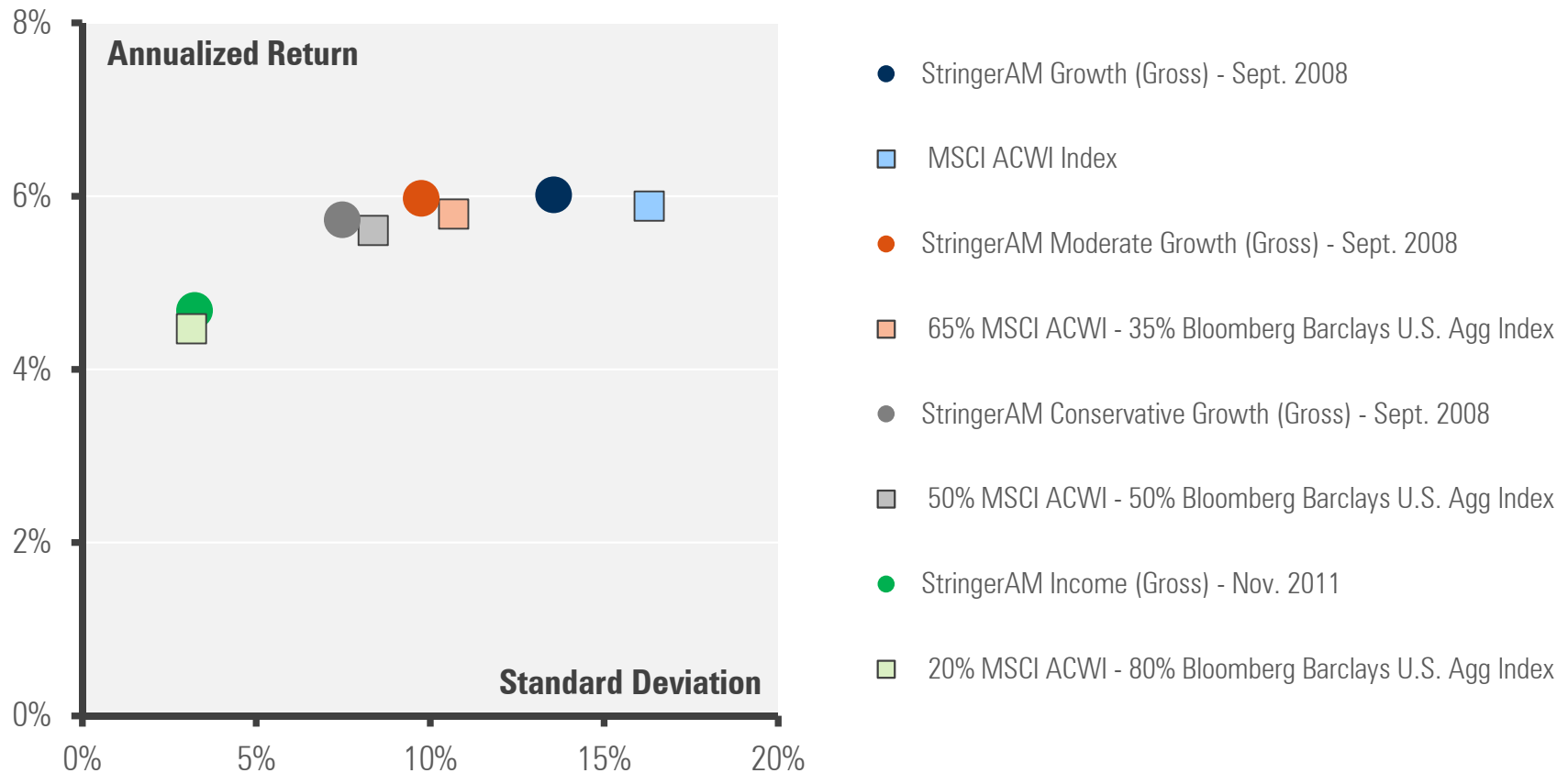

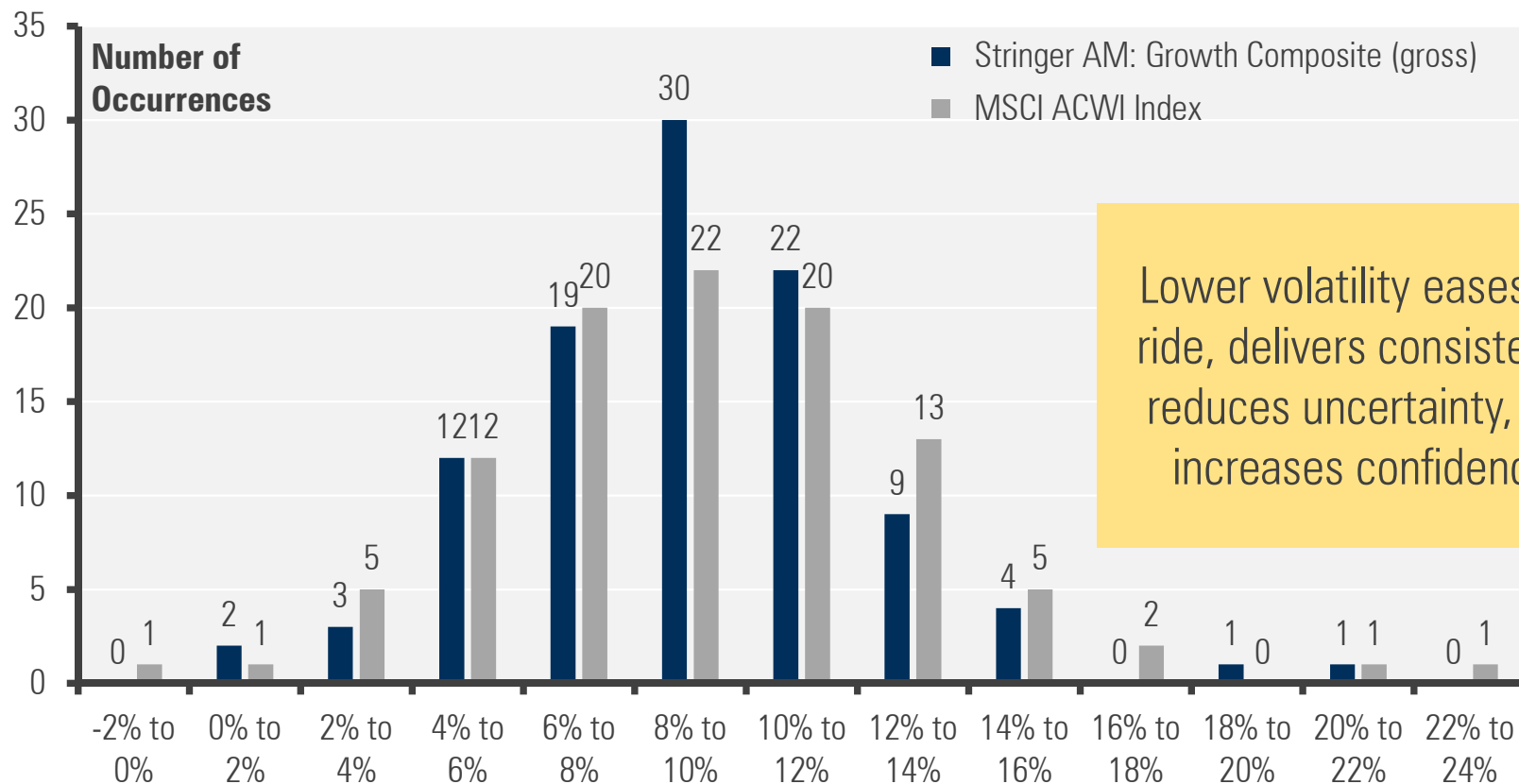
RISK/REWARD PLOT¹: SINCE INCEPTION TO FEBRUARY 2020

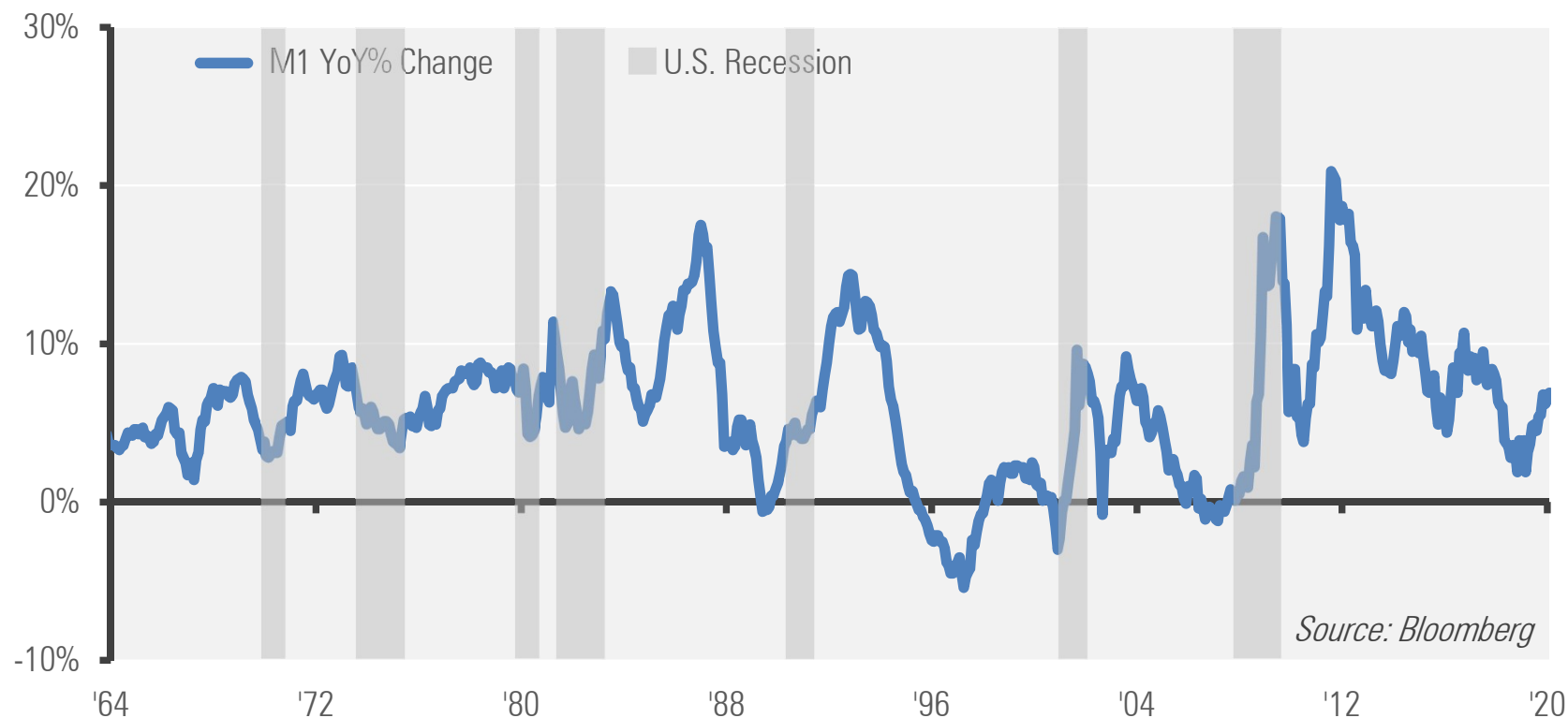

BROAD OUTLOOK

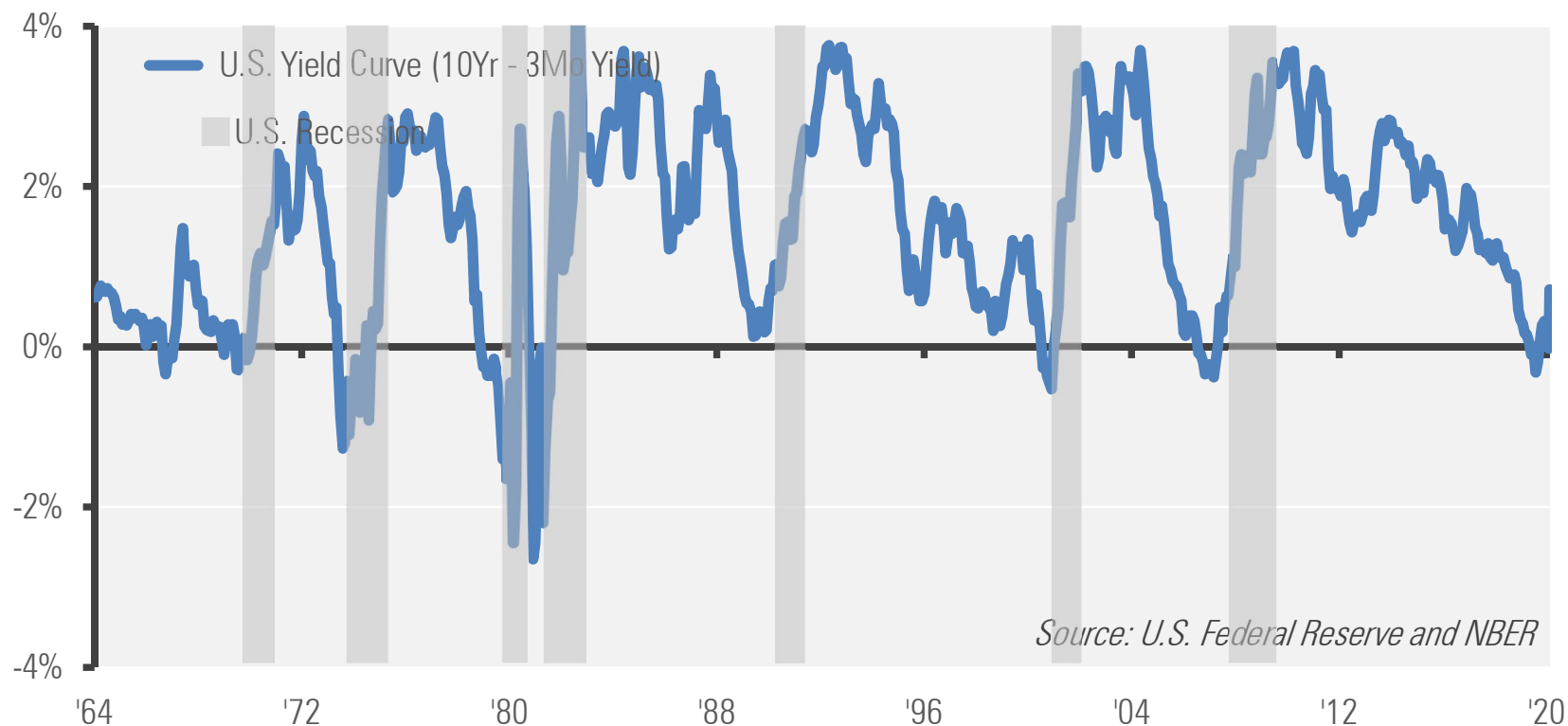
- » In our view, the odds of a recession have increased from being a possibility to being a probability.
- » The typical recession, like we saw from Q3 1990 to Q1 1991 and Q1 2001 to Q4 2001, tends to last just a matter of months and is then followed by robust economic growth driven by pent up demand.
- » Several broad economic areas we follow to develop our expectations for economic and market conditions indicate that the U.S. is entering the most challenging economic and market environment of the current business cycle.
- » Importantly, regardless of the type of shock (e.g. economic damage from a pandemic, housing crisis, oil market shock, etc.), the ramifications tend to be felt across this broad spectrum of leading economic indicators.
- » In aggregate, our indicators suggest that the economy will struggle for growth in the coming months and is likely heading for a brief recession, followed by a strong economic rebound.
- » The lack of financial leverage combined with the resilience of the labor market suggest that this downturn will be brief.
- » With odds of significant economic slowdown increasing, we recently reduced our exposures to economic risk and hold more cash and short-term Treasury ETFs depending on the Strategy.
- » This active risk management can help to protect the downside while leaving dry powder to pick up some great values when our work suggests that the time is right.

Near-Term Leading Indicators: Liquidity (M1) Growth



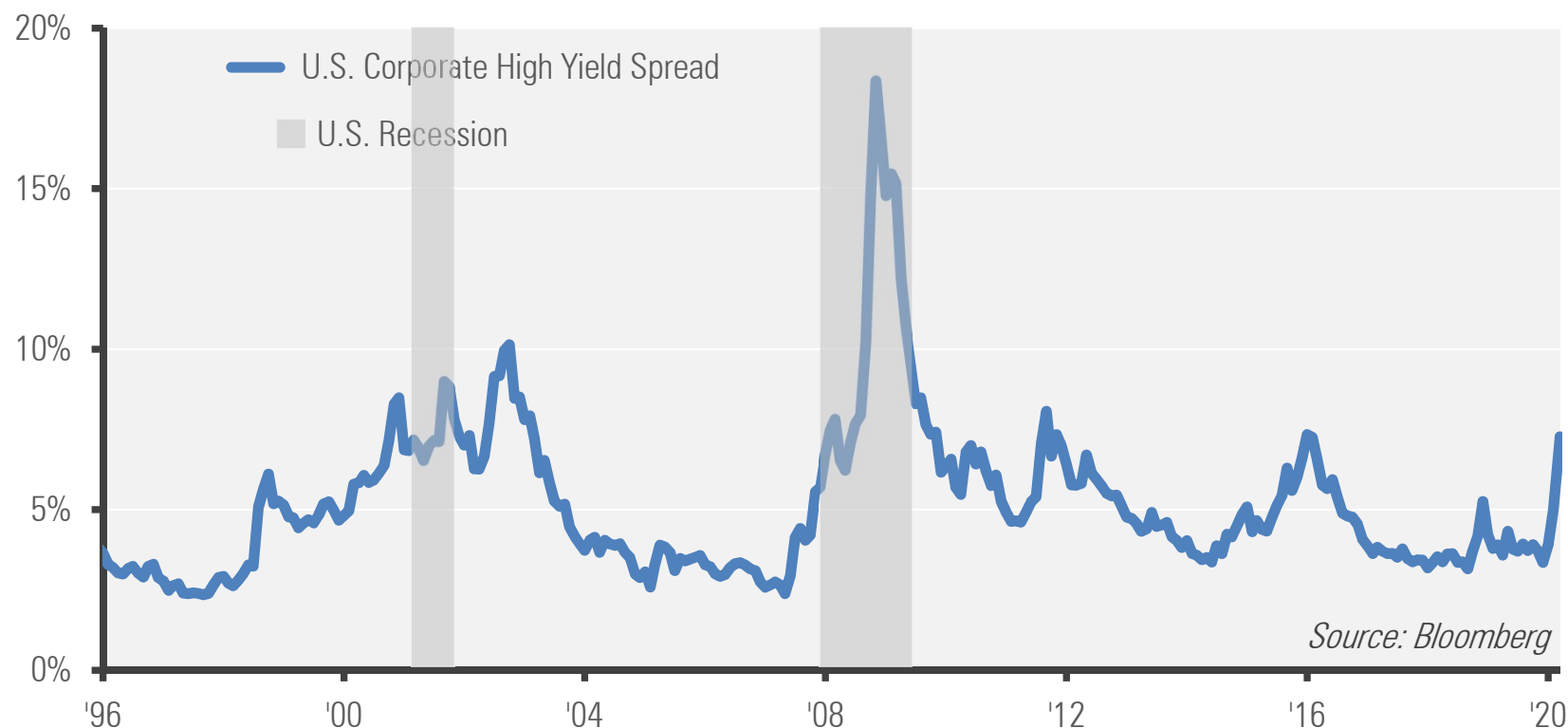
- » Monetary conditions are heavily influenced by Fed monetary policy and we can track the Fed's policy decisions and their effects on monetary conditions.
- » One excellent way to do this is to track liquidity growth as measured by M1 growth.
- » M1 growth accelerated last year and is still in a positive trend reflecting the Fed's shift in policy to be more accommodative, which we view as a positive sign.

Long-Term Leading Indicators: Yield Curve



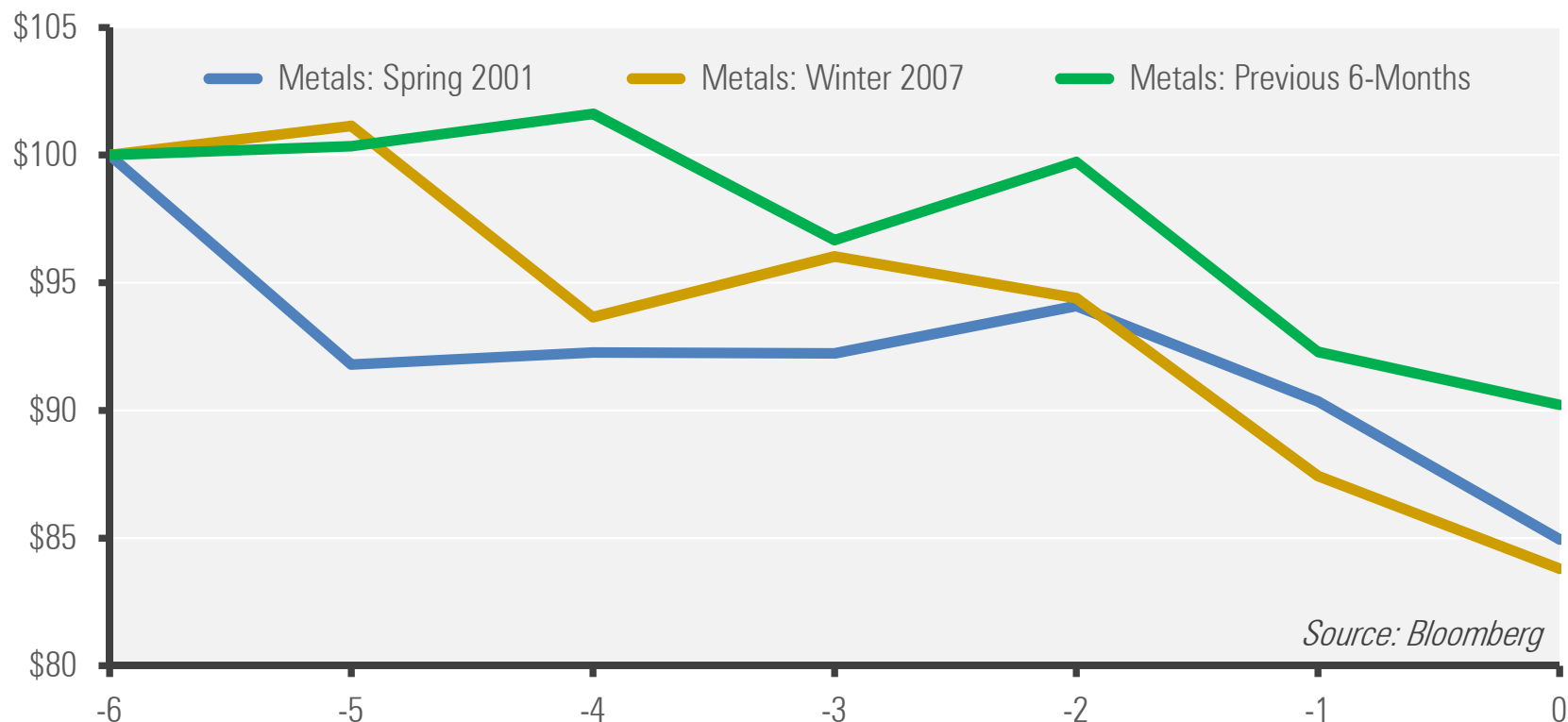
- » Two important measures of credit conditions are the yield curve and credit spreads.
- » The yield curve, which compares the level of short-term and long-term interest rates, inverted about a year ago when long-term interest rates dropped below short-term interest rates.
- » That scenario created a cautionary environment where risks to the economy are elevated for at least 18 months.

Near-Term Leading Indicators: Credit Spreads



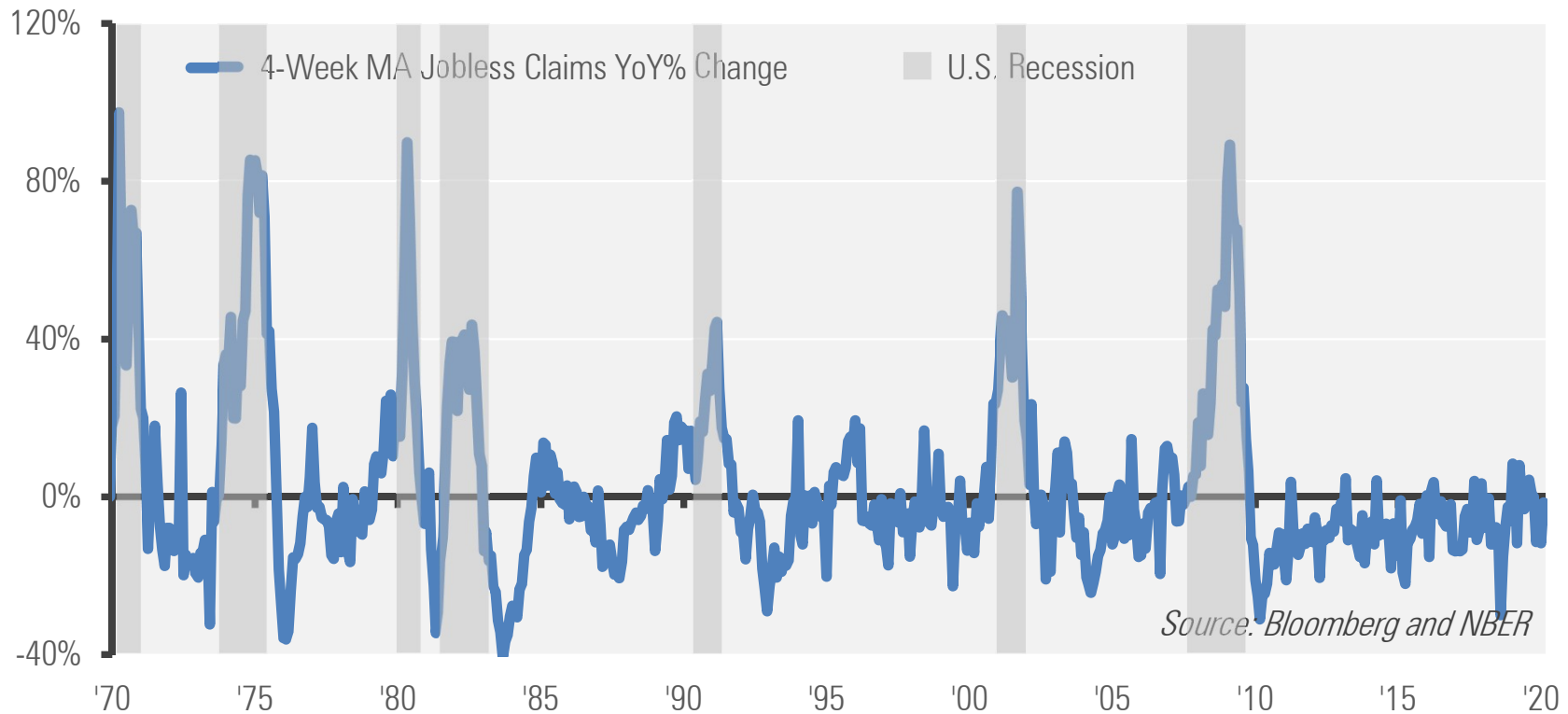
- » Credit spreads reflect the difference in interest rates between U.S. Treasury bonds as a base line and other debt instruments.
- » Recently, we have seen credit spreads widening, especially for corporate bonds.
- » This widening suggests that the bond market is pricing in more credit risk.
- » This is not a good sign for the economy and suggests that we may be entering a recession.

Our Indicators Now Suggest Recession



- » We look for a healthy level of demand in the economy because when demand subsides, economic growth can weaken. One proxy for demand that we track is the change in prices of industrial metals.
- » Rising industrial metals' prices suggests growing demand and prices tend to decline significantly on the cusp of recession.
- » Current industrial metals' price declines are now looking more similar to the price actions that we saw prior to the last two recessions.

Near-Term Leading Indicators: Jobless Claims



- » Weekly unemployment claims (layoffs) is one of our favorite near-term leading economic indicators.
- » During times of deep economic strife, layoff increase significantly, often rising 15-20% year-over-year prior to recessions.
- » While the number of layoffs is not increasing, it is not falling either.
- » In aggregate, these indicators suggest that the economy will struggle for growth in the coming months and is likely heading for a brief recession, followed by a strong rebound.

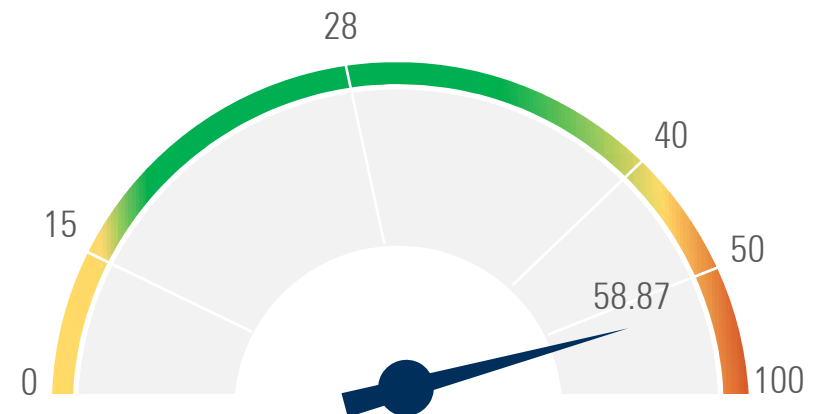
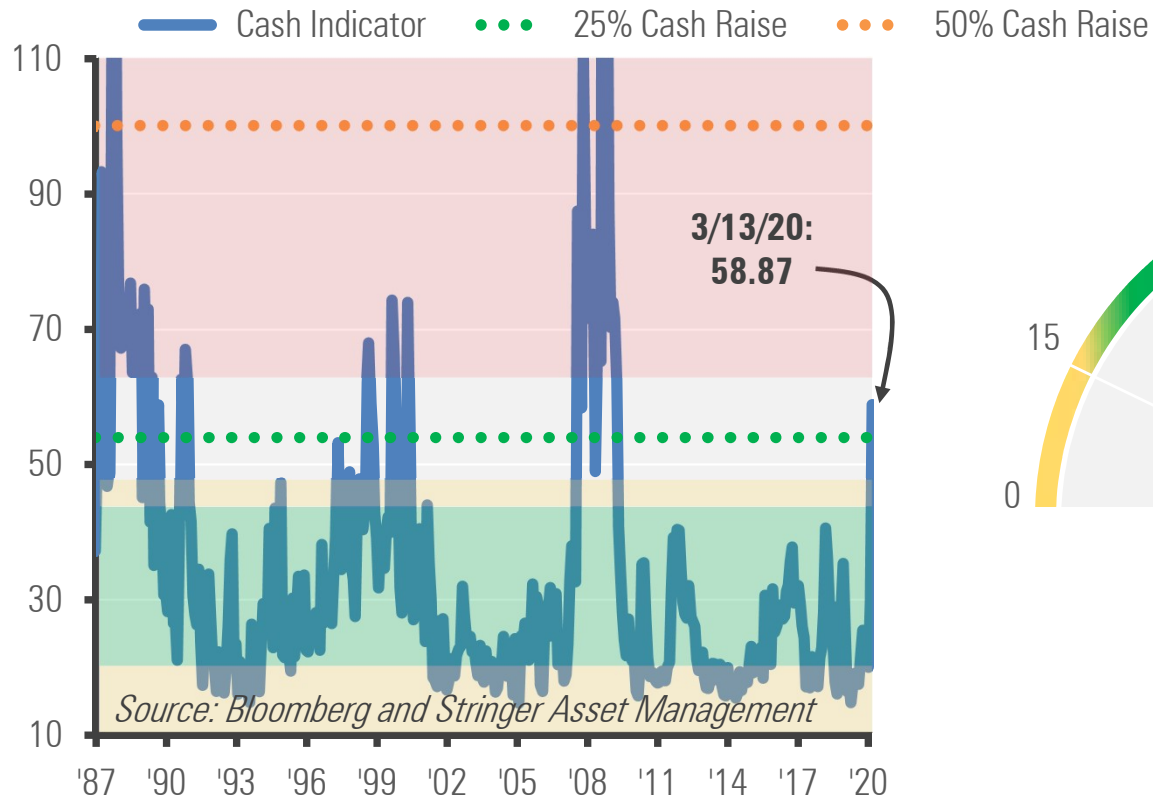

Index Definitions:

Bloomberg Barclays U.S. Aggregate Bond Index – This Index provides a measure of the U.S. investment grade bond market, which includes investment grade U.S. Government bonds, investment grade corporate bonds, mortgage pass-through securities and asset-backed securities that are publicly offered for sale in the United States. The securities in the Index must have at least 1 year remaining to maturity. In addition, the securities must be denominated in US dollars and must be fixed rate, nonconvertible and taxable.

MSCI ACWI (Net) Index – This Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI Index consists of 23 developed and 23 emerging market country indexes. Net total return includes the reinvestment of dividends after the deduction of withholding taxes, using a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties.

S&P 500 Index – This Index is a capitalization-weighted index of 500 stocks. The Index is designed to measure performance of a broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

Statistical Definitions:

Standard deviation – A statistical measure of volatility, standard deviation is often used as an indicator of the ‘risk’ associated with a return series. Standard deviation of return measures the average deviations of a return series from its mean. A large standard deviation implies that there have been large swings in the return series of the manager.

Alpha – Alpha is a measure of risk (beta)-adjusted return. Alpha measures the difference between a portfolio’s actual returns and what it might be expected to deliver based on its level of risk. In an ideal sense, higher risk should equate to higher return. A positive alpha means the fund has beaten expectations. A negative alpha means that the fund has failed to match performance given its level of risk. If two managers have the same return, but one has a lower beta, that manager would have a higher alpha.

Beta – This represents the systematic risk of a portfolio and measures its sensitivity to a benchmark. A portfolio with a beta of one is considered to be as risky as the benchmark and would therefore provide expected returns equal to those of the market benchmark during both up and down periods. A portfolio with a beta of two would move approximately twice as much as the benchmark.

Yield – Portfolio and benchmark yields are calculated using a harmonic weighted average of the net dividends per share during the past 12 months for each holding as of the date identified at their respective target weighting.

Principal Risks:

Allocation risk – The performance of the portfolio relative to its benchmark will depend largely on the decisions to strategic asset allocation and tactical adjustments made to the asset allocation.
