



BROAD OUTLOOK

- » Investors benefit the most over time by making less emotional decisions with regards to their portfolios.
- » Helping investors overcome their behavioral biases is at the heart of everything we do.
- » Every few years, it seems the markets find another new idea that steals the headlines and dominates short-term returns.
- » Meanwhile, though many market participants are enthused by the shiny new objects of the day, amazing investment opportunities are often being ignored at least for a time.
- » Currently, with a very few large cap U.S. stocks driving equity market returns, we are seeing both the fear of missing out (FOMO) trades and an abundance of opportunities that can be found outside of the spotlight.
- » By staying true to a disciplined process and not succumbing to FOMO, investors can rest easier knowing their investments are allocated across a wide range of attractive opportunities.
- » Investors only need to look more broadly at the attractive valuations found outside of the latest market darlings to find areas likely to do well going forward.

» We anticipate that the coming months will bring similar opportunities for disciplined investors.



HOW NARROW HAS THE MARKET RECOVERY BEEN?

In fact, we think that markets are packed with opportunities that have been neglected in the current narrow market recovery. Consider that while the capitalization-weighted S&P 500 Index has appreciated 8.9% through May, an equal-weighted version of the same index is down more than 1.4% and the Russell 2000 Index of small companies is relatively flat at -0.6%.

Looking at this performance disparity more deeply reveals the following according to Capital Economics¹:

- » a market-cap weighted portfolio of the largest five companies in the S&P 500 Index returned roughly 40% through May, compared to only about 2% for the next 95 largest constituents and less than 1% for the remaining 400 firms; and
- » approximately 70% of the current constituents of the S&P 500 Index have risen in price by less than the overall Index, around half have actually fallen in value this year, and about a quarter are down more than 10%.

INVESTMENT IMPLICATIONS

- » Just as we saw the number of investment opportunities increase during the narrowly led pandemic work-from-home market, we are seeing more attractive opportunities elsewhere.
- » These opportunities include U.S. equities that have lagged or even suffered price declines this year as well as alternative assets, such as MLPs, whose earning's potential and yields remain strong while their prices have lagged.
- » Overall, our largest broad equity sector overweights are to health care, energy (via MLPs), and consumer staples.
- » Furthermore, because of the stretched valuations of the market capitalization-weighted indices, traditional fixed income looks very attractive as it can both act as a ballast to offset potential equity market risk while also generating attractive current income.
- » By staying true to a disciplined process and not succumbing to FOMO, investors can rest easier knowing their investments are allocated across a wide range of attractive opportunities.
- » The stock market's recent concentration has only made those neglected areas that much more attractive.
- » Investors only need to look more broadly at the attractive valuations found outside of the latest market darlings to find areas likely to do well going forward.



Index Definitions:

Bloomberg Barclays U.S. Aggregate Bond Index – This Index provides a measure of the U.S. investment grade bond market, which includes investment grade U.S. Government bonds, investment grade corporate bonds, mortgage pass-through securities and asset-backed securities that are publicly offered for sale in the United States. The securities in the Index must have at least 1 year remaining to maturity. In addition, the securities must be denominated in US dollars and must be fixed rate, nonconvertible and taxable.

MSCI ACWI (Net) Index – This Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI Index consists of 23 developed and 23 emerging market country indexes. Net total return includes the reinvestment of dividends after the deduction of withholding taxes, using a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties.

S&P 500 Index – This Index is a capitalization-weighted index of 500 stocks. The Index is designed to measure performance of a broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

FT Wilshire 5000 Index Price Return – This Index is a broad-based market capitalization-weighted index that seeks to capture 100% of the United States investible market. The Index includes all U.S. equities with readily available prices, with thinly-traded and bulletin-board issues excluded. As with all market capitalization-weighted indices, this Index overweights companies with a higher firm value and underweights those with a lower firm value. The price return excludes dividends and reinvestments of income.



Statistical Definitions:

Standard deviation – A statistical measure of volatility, standard deviation is often used as an indicator of the 'risk' associated with a return series. Standard deviation of return measures the average deviations of a return series from its mean. A large standard deviation implies that there have been large swings in the return series of the manager.

Alpha – Alpha is a measure of risk (beta)-adjusted return. Alpha measures the difference between a portfolio's actual returns and what it might be expected to deliver based on its level of risk. In an ideal sense, higher risk should equate to higher return. A positive alpha means the fund has beaten expectations. A negative alpha means that the fund has failed to match performance given its level of risk. If two managers have the same return, but one has a lower beta, that manager would have a higher alpha.

Beta – This represents the systematic risk of a portfolio and measures its sensitivity to a benchmark. A portfolio with a beta of one is considered to be as risky as the benchmark and would therefore provide expected returns equal to those of the market benchmark during both up and down periods. A portfolio with a beta of two would move approximately twice as much as the benchmark.

Yield – Portfolio and benchmark yields are calculated using a harmonic weighted average of the net dividends per share during the past 12 months for each holding as of the date identified at their respective target weighting.



Principal Risks:

Allocation risk - The performance of the portfolio relative to its benchmark will depend largely on the decisions to strategic asset allocation and tactical adjustments made to the asset allocation. At times, judgments as to the asset classes in which the portfolio should invest may prove to be wrong, as some asset classes may perform worse than others or the equity markets generally from time to time or for extended periods of time. Market risk - The value of securities in the portfolio may decline due to daily fluctuations in the securities markets, including fluctuation in interest rates, national and international economic conditions and general equity market conditions. Management style risk - To the extent the portfolio focuses on a particular style of stocks, such as growth or value, its performance may at times be better or worse than that of similar portfolios with other focuses or that have a broader investment style. Business and sector risk - From time to time, a particular set of circumstances may affect a particular industry or certain companies within an industry, while having little or no impact on other industries or other companies within the industry. Large company risk - The portfolio may invest in larger, more established companies, which may be unable to respond quickly to new competitive challenges such as changes in consumer tastes or innovative smaller competitors. Also, large companies are sometimes unable to attain the high growth rates of successful, smaller companies, especially during extended periods of economic expansions. Mid-sized company risk - The portfolio may invest in mid-cap companies, which may be more vulnerable to adverse business or economic events than larger, more established companies. In particular, these mid-sized companies may pose additional risks, including liquidity risk, because these companies tend to have limited product lines, markets and financial resources, and may depend upon a relatively small management group. Small company risk - The portfolio may invest in smaller companies, which generally have less experienced management teams, serve smaller markets, and find it more difficult to obtain financing for growth or potential development than larger companies. Real Estate Investment Trust ("REIT") risk - The portfolio may invest in ETFs or other pooled investment vehicles that invest in REITs. REITs are susceptible to the risks associated with investing in real estate generally, including, among others, declines in the value of real estate, lack of ability to access the credit markets and defaults by borrowers or tenants.
