2. Stringer Asset Management LLC is a registered investment adviser that generally provides services through model portfolios on a sub-advisory business. The firm primarily allocates client’s investment management assets among exchange-traded funds (“ETFs”) and secondarily among mutual funds.
3. The Conservative Growth Composite includes all portfolios that invest their assets in equity, fixed income and alternative exchange-traded funds selected from the global investment opportunity set. The Conservative Growth Composite has risk characteristics lower than that of the broad equity market and include but are not limited to equity risk, international investing risk and credit risk.
4. The benchmark is a blend of 50% MSCI ACWI (Net) Index and 50% Barclays U.S. Aggregate Bond Index rebalanced quarterly as of January 1, 2016. The benchmark is market-cap weighted and is designed to measure the equity market performance of developed and emerging market indices. Sources of foreign exchange rates may be different between the composite and the benchmark; however, there have not been material differences to date. Prior to January 1, 2016, the blended benchmark was 50% MSCI World Index and 50% Barclays U.S. Aggregate Bond Index re-

balanced quarterly. The benchmark was retroactively changed to more closely follow our investment strategy. Prior to February 1, 2015, the blended benchmark was 35% Russell 3000 Index, 15% MSCI ACWI xUS Index and 50% Barclays U.S. Aggregate Bond Index rebalanced quarterly. The benchmark was retroactively changed to more closely follow our investment strategy.

5. For the period August 31, 2008 through January 31, 2013, the performance represents the portfolio track record established by the Gary Stringer while affiliated with a prior firm. All investment decisions at the prior firm were made by Gary Stringer. A review of this track record for compliance with the portability requirements of the GIPS standards was conducted by Ashland Partners & Company LLP for the periods August 31, 2008 to January 31, 2013.
6. Results are based on fully discretionary accounts under management, including those accounts no longer with the firm.
7. The U.S. Dollar is the currency used to express performance. Past performance is not indicative of future results. Returns are presented gross and net of fees and include the reinvestment of all income. Gross returns are shown as supplemental information and are started gross of all fees and transaction costs; net returns are reduced by all fees and transaction costs incurred. Net of fee performance is calculated using actual fees incurred.
8. In addition to a management fee, accounts in the composite may pay an all-inclusive fee based on a percentage of assets under management. Other than brokerage commissions, this may include fees for portfolio monitoring, consulting services, and in some cases, custodial services. Wrap fee schedules are provided by independent wrap sponsors and are available upon request from the respective wrap sponsor. The all-inclusive fee to a client may vary between 1% to 3%.
9. The annual composite dispersion presented is an equal-weighted standard deviation calculated for the accounts in the composite the entire year using pure gross returns.
10. The three-year annualized standard deviation measures the variability of the composite and the benchmark returns over the preceding 36-month period using pure gross returns.
11. The Stringer investment management fee for the composite typically falls within the 0.40% to 0.50% range. Actual investment management fees may vary.

14. The Conservative Growth Composite was created March 2013 and the Conservative Growth Composite was inceptioned in August 2008.

Bundled fee/wrap accounts are included in the Conservative Growth Composite and represent a percentage of the composite assets: 2013: 81%, 2014: 84%, 2015: 99%, 2016: 100%, 2017: 100%, 2018: 100%, 2019: 100%, 2020: 100%, 2021: 100%, and 2022: 100%. No bundled fee/wrap accounts were included in the composite prior to 2013.
