


BROAD OUTLOOK

- » First quarter economic growth was stronger than the GDP report suggested.
- » In addition, economic activity has increased globally.
- » The percentage of the labor force not employed has reached an all-time low.
- » Massive investments in Research & Development (R&D) will drive innovation and create benefits that will last for years to come.

GDP Underestimated Economic Growth






» Like in Q1 2022, Q1 2024 GDP growth underestimated economic growth.

- » We can get a clearer picture of U.S. economic growth by also considering real final sales to private domestic purchasers, which excludes the effects of foreign trade as well as changes in inventories and government spending.
- » While real GDP growth slowed in the first quarter to a 1.6% annualized rate, real final sales to private domestic purchasers was a more robust 3.1% annualized rate.

Economic Growth Picking Up Globally





- » Additionally, economic growth seems to be spreading globally as economic activity around the world has recently gained momentum.
- » As reflected in the JP Morgan Global Composite Purchasing Managers Index (PMI), the rate of global economic expansion improved to a ten-month high in April.
- » It appears that the worst of the global economic slowdown may be behind us, at least for the time being.

Record Low Unemployment






- » While the official unemployment rate does not include those not looking for work, our analysis includes all civilians 16 or older whether they are looking for work or not.
- » In the 1950s and early 1960s, > 20% of the labor force on average was not working.
- » From the middle-to-late 1960s through the 1980s, the rate of unemployed declined
- » From 1990 on, that average held steady at about 11%.
- » Today, we are down to about 6% of the civilian labor force not employed, which is an all-time low.

Research & Development Booming





- » Helping make the labor force more productive and drive innovation, investment in research and development (R&D), which drives innovation across the economy, has been growing at a brisk pace.
- » For example, at the height of the 1990s excitement around the information revolution, R&D spending peaked at about 4% of GDP or a \$422B annualized rate.
- » In the first quarter of 2024, R&D investment has climbed to an all-time high of 5.5% of GDP or more than a \$1.5T annualized rate.



Index Definitions:

Bloomberg Barclays U.S. Aggregate Bond Index – This Index provides a measure of the U.S. investment grade bond market, which includes investment grade U.S. Government bonds, investment grade corporate bonds, mortgage pass-through securities and asset-backed securities that are publicly offered for sale in the United States. The securities in the Index must have at least 1 year remaining to maturity. In addition, the securities must be denominated in US dollars and must be fixed rate, nonconvertible and taxable.

MSCI ACWI (Net) Index – This Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI Index consists of 23 developed and 23 emerging market country indexes. Net total return includes the reinvestment of dividends after the deduction of withholding taxes, using a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties.

S&P 500 Index – This Index is a capitalization-weighted index of 500 stocks. The Index is designed to measure performance of a broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.



Statistical Definitions:

Standard deviation – A statistical measure of volatility, standard deviation is often used as an indicator of the 'risk' associated with a return series. Standard deviation of return measures the average deviations of a return series from its mean. A large standard deviation implies that there have been large swings in the return series of the manager.

Alpha – Alpha is a measure of risk (beta)-adjusted return. Alpha measures the difference between a portfolio's actual returns and what it might be expected to deliver based on its level of risk. In an ideal sense, higher risk should equate to higher return. A positive alpha means the fund has beaten expectations. A negative alpha means that the fund has failed to match performance given its level of risk. If two managers have the same return, but one has a lower beta, that manager would have a higher alpha.

Beta – This represents the systematic risk of a portfolio and measures its sensitivity to a benchmark. A portfolio with a beta of one is considered to be as risky as the benchmark and would therefore provide expected returns equal to those of the market benchmark during both up and down periods. A portfolio with a beta of two would move approximately twice as much as the benchmark.

Yield – Portfolio and benchmark yields are calculated using a harmonic weighted average of the net dividends per share during the past 12 months for each holding as of the date identified at their respective target weighting.



Principal Risks:

Allocation risk - The performance of the portfolio relative to its benchmark will depend largely on the decisions to strategic asset allocation and tactical adjustments made to the asset allocation. At times, judgments as to the asset classes in which the portfolio should invest may prove to be wrong, as some asset classes may perform worse than others or the equity markets generally from time to time or for extended periods of time. Market risk - The value of securities in the portfolio may decline due to daily fluctuations in the securities markets, including fluctuation in interest rates, national and international economic conditions and general equity market conditions. Management style risk - To the extent the portfolio focuses on a particular style of stocks, such as growth or value, its performance may at times be better or worse than that of similar portfolios with other focuses or that have a broader investment style. Business and sector risk - From time to time, a particular set of circumstances may affect a particular industry or certain companies within an industry, while having little or no impact on other industries or other companies within the industry. Large company risk - The portfolio may invest in larger, more established companies, which may be unable to respond quickly to new competitive challenges such as changes in consumer tastes or innovative smaller competitors. Also, large companies are sometimes unable to attain the high growth rates of successful, smaller companies, especially during extended periods of economic expansions. Mid-sized company risk - The portfolio may invest in mid-cap companies, which may be more vulnerable to adverse business or economic events than larger, more established companies. In particular, these mid-sized companies may pose additional risks, including liquidity risk, because these companies tend to have limited product lines, markets and financial resources, and may depend upon a relatively small management group. Small company risk - The portfolio may invest in smaller companies, which generally have less experienced management teams, serve smaller markets, and find it more difficult to obtain financing for growth or potential development than larger companies. Real Estate Investment Trust ("REIT") risk - The portfolio may invest in ETFs or other pooled investment vehicles that invest in REITs. REITs are susceptible to the risks associated with investing in real estate generally, including, among others, declines in the value of real estate, lack of ability to access the credit markets and defaults by borrowers or tenants.
