




BROAD OUTLOOK

- » Private Sector Dominates: Household spending and residential investment drive economic activity and make up 72% of U.S. GDP, while government spending accounts for only 17%.
- » Jobs Creation Drives Growth: Current healthy jobs creation boosts income and consumer spending, while improving living standards.
- » Private Sector Stability: Most households and businesses are financially healthy, with manageable debt levels outside the lowest income group.
- » **Investment Strategy**: We favor U.S. equities, such as consumer discretionary, financials, information technology, and telecom, while underweighting U.S. Treasury bonds.
 - For fixed income, we are focused on attractively yielding high quality corporate bonds, assetbacked, and mortgage-backed securities.

2024 Components of GPD (includes estimates)






- » We often say that the government can create headwinds and tailwinds for particular industries and economic sectors.
- » For example, increased defense spending can be a tailwind for defense contractors while more regulation or tariffs can create headwinds to the automobile industry.
- » However, it is the private sector in aggregate that dominates the economy.

Monthly Jobs Creation





- » Jobs creation continues its positive momentum though we expect volatility around the employment numbers, as well as revisions.
- » We favor looking at averages and trends over time.
- » The current figures are also settling in at around 166,000 jobs per month average.
- » This amounts to nearly two million new jobs created every year, which drives personal income and spending higher.



Annual % U.S. Fixed Income Issuance






- » While the U.S. Federal Reserve sets short-term interest rates, financial market participants set the rate longer-term bonds, such as the benchmark 10-year Treasury bond.
- » We expect that the U.S. Treasury will have to issue more 10-year debt to fund continued deficit spending in the months to come.
- » As more of this debt comes to market, the market will decide on the yield.

Fixed Income Yield to Worst





- » We are finding a lot of great opportunities to take advantage of higher yields and/or better relative value opportunities in areas like investment grade corporate bonds, asset-backed securities, and mortgage-backed securities.
- » When comparing yield-to-worst across these investment grade fixed income sectors, the aforementioned sectors offer a nice income advantage over Treasuries.



INVESTMENT IMPLICATIONS

- » We favor U.S. equities over other asset classes. At the sector level, we continue to be overweight consumer discretionary, financials, information technology, and telecom services.
- » Recognizing the risks associated with continued fiscal deficits and rising government debt burdens, we are underweight U.S. Treasury bonds relative to the aggregate bond index and overweight other sectors of the bond market that offer a better risk/reward tradeoff in our view.
- » We are finding a lot of great opportunities to take advantage of higher yields and/or better relative value opportunities in areas like investment grade corporate bonds, asset-backed securities, and mortgage-backed securities.
- » Overall, our Strategies generally offer higher yields than their respective benchmarks at lower levels of relative risk.
- » We think this positioning is set to handle market volatility stemming from headline risks or more fundamental risks to the economy and financial markets.



Index Definitions:

Bloomberg Barclays U.S. Aggregate Bond Index – This Index provides a measure of the U.S. investment grade bond market, which includes investment grade U.S. Government bonds, investment grade corporate bonds, mortgage pass-through securities and asset-backed securities that are publicly offered for sale in the United States. The securities in the Index must have at least 1 year remaining to maturity. In addition, the securities must be denominated in US dollars and must be fixed rate, nonconvertible and taxable.

MSCI ACWI (Net) Index – This Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI Index consists of 23 developed and 23 emerging market country indexes. Net total return includes the reinvestment of dividends after the deduction of withholding taxes, using a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties.

S&P 500 Index – This Index is a capitalization-weighted index of 500 stocks. The Index is designed to measure performance of a broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.



Statistical Definitions:

Standard deviation – A statistical measure of volatility, standard deviation is often used as an indicator of the 'risk' associated with a return series. Standard deviation of return measures the average deviations of a return series from its mean. A large standard deviation implies that there have been large swings in the return series of the manager.

Alpha – Alpha is a measure of risk (beta)-adjusted return. Alpha measures the difference between a portfolio's actual returns and what it might be expected to deliver based on its level of risk. In an ideal sense, higher risk should equate to higher return. A positive alpha means the fund has beaten expectations. A negative alpha means that the fund has failed to match performance given its level of risk. If two managers have the same return, but one has a lower beta, that manager would have a higher alpha.

Beta – This represents the systematic risk of a portfolio and measures its sensitivity to a benchmark. A portfolio with a beta of one is considered to be as risky as the benchmark and would therefore provide expected returns equal to those of the market benchmark during both up and down periods. A portfolio with a beta of two would move approximately twice as much as the benchmark.

Yield – Portfolio and benchmark yields are calculated using a harmonic weighted average of the net dividends per share during the past 12 months for each holding as of the date identified at their respective target weighting.



Principal Risks:

Allocation risk - The performance of the portfolio relative to its benchmark will depend largely on the decisions to strategic asset allocation and tactical adjustments made to the asset allocation. At times, judgments as to the asset classes in which the portfolio should invest may prove to be wrong, as some asset classes may perform worse than others or the equity markets generally from time to time or for extended periods of time. Market risk - The value of securities in the portfolio may decline due to daily fluctuations in the securities markets, including fluctuation in interest rates, national and international economic conditions and general equity market conditions. Management style risk - To the extent the portfolio focuses on a particular style of stocks, such as growth or value, its performance may at times be better or worse than that of similar portfolios with other focuses or that have a broader investment style. Business and sector risk - From time to time, a particular set of circumstances may affect a particular industry or certain companies within an industry, while having little or no impact on other industries or other companies within the industry. Large company risk - The portfolio may invest in larger, more established companies, which may be unable to respond quickly to new competitive challenges such as changes in consumer tastes or innovative smaller competitors. Also, large companies are sometimes unable to attain the high growth rates of successful, smaller companies, especially during extended periods of economic expansions. Mid-sized company risk - The portfolio may invest in mid-cap companies, which may be more vulnerable to adverse business or economic events than larger, more established companies. In particular, these mid-sized companies may pose additional risks, including liquidity risk, because these companies tend to have limited product lines, markets and financial resources, and may depend upon a relatively small management group. Small company risk - The portfolio may invest in smaller companies, which generally have less experienced management teams, serve smaller markets, and find it more difficult to obtain financing for growth or potential development than larger companies. Real Estate Investment Trust ("REIT") risk - The portfolio may invest in ETFs or other pooled investment vehicles that invest in REITs. REITs are susceptible to the risks associated with investing in real estate generally, including, among others, declines in the value of real estate, lack of ability to access the credit markets and defaults by borrowers or tenants.
